## FOREWORD

This Handbook gives details of the members of the Planning and Environment Bar Association ("PEBA"). Our members are barristers specialising in the fields of planning, environment, highways, rating, compulsory purchase, housing, town and village greens and other aspects of local government administration and finance. We undertake a wide range of advisory work and appearances in the civil and criminal courts, public inquiries, examinations, hearings and tribunals on behalf of anyone in need of expert advice and representation. Several of our members are also trained mediators.

In representing its members, PEBA is in frequent contact with Government departments and agencies, organisations such as the National Planning Forum and other professional bodies. There is constant change in our fields of activity. The Coalition Government has embarked on reform of the system of planning and local government via its Localism Bill and review of National Planning Policy. PEBA has responded to both these initiatives by making formal representations and by maintaining active liaison with CLG. As well as our regular involvement with PINS, we have also established good relations with the IPC and are, as ever, seeking to assist those responsible for policy formulation, administrators and decision makers in a changing environment in which the Bar, together with local government and planning systems, faces many challenges.

We place great emphasis on continuing education for our members. The National Conference on 10 June 2011 will examine the theme of 'Building the Recovery'. Our keynote speaker is Mr Justice Lindblom. On May 16 2011 we participated in a joint seminar on the Environmental Tribunal with the United Kingdom Environmental Law Association, following our successful collaboration earlier in the year on the Localism Bill.

We have long supported pro bono representation for persons who would otherwise be unable to obtain legal help. We support the DCLG funded Planning Aid scheme and a number of our members are members of the Bar Pro Bono Panel.

## **INSTRUCTING A MEMBER OF PEBA**

Any member of the Association may accept instructions from a solicitor. Alternatively, in the case of most, if not all members, instructions may be given by a member of any of the professions recognised by the Bar Council for the purpose of Licensed Access (formerly Direct Professional Access, latterly BarDIRECT).

## **LICENSED ACCESS**

Since April 1989, members of a number of professional bodies, in addition to solicitors, have been able to seek advice direct from barristers (counsel), and may instruct barristers in non-court litigation in relation to matters which are within their normal professional expertise.

This scheme (previously known as Direct Professional Access (DPA)) has proved to be a popular way of instructing members of the Association, particularly in relation to obtaining legal advice and representation before inquiries and tribunals—including the Upper Tribunal (Lands Chamber)—and in magistrates courts.

The bodies whose members may instruct barristers, so far as relevant to the types of work carried out by members of the Association, currently include the following:

- Architects Registration Board
- Association of Consultant Architects
- Commissioner for Local Administration
- The Royal Institute of British Architects
- The Royal Institution of Chartered Surveyors
- The Royal Town Planning Institute.

The scheme does not extend to instructing barristers to appear in the higher courts—including County Courts, the Crown Court, and the Employment Appeal Tribunal. Nor does it operate if at any stage a barrister considers that the interests of the lay client or the administration of justice require that a solicitor be instructed.

In addition, a number of other bodies have been granted group licences (formerly under the BarDIRECT scheme), enabling their members to instruct members of the Association, but only on certain matters. They include the following:

- The Academy of Experts
- The Institute of Legal Executives
- The Landscape Institute.

The contact details for all of these bodies are in Part Five of this Handbook. Both the Bar Council and the relevant professional body can provide guidance notes on how to instruct a barrister.

## **PUBLIC ACCESS**

Since July 2004, it has been possible for members of the public to instruct barristers directly, without the need to employ a professionally qualified intermediary, in relation to certain categories of work.

However, this applies only where the barrister concerned, and at least one clerk in his or her chambers, has been appropriately trained. Even then, it does not apply where the barrister considers that the case is complex and will require work to be undertaken by a solicitor or other qualified person, or that the interests of the lay client require the involvement of such a person, or that the proposed fee is insufficient. ## **THE BAR PRO BONO UNIT**

The Unit is a charity that was established in 1996 to provide *pro bono* (free) legal advice and representation in deserving cases where the applicant is unable to afford legal assistance and where Legal Aid is not available.

Advice and representation is provided by barristers who have volunteered to join the Bar Pro Bono Panel. The Panel consists of barristers—both juniors and QCs—from all over England and Wales, including members of the Association, each of whom has offered his or her services free of charge for at least three days a year.
